1. Participation fee for the whole period of the exhibition fair (including 18% VAT)	1 sq.m. of the equipped area (the exhibition stand) - 100 1 sq.m. of non-equipped area (without exhibition stand) - 500 +20 % block of power sockets 220V. 1 sq.m. of separate exhibition area (not of an exhibition facility) - 300 Registration fee - 100

3. Participation in the catalog	Placement of information (up to 50 words) about the Exhibitor in the Official catalog of the Exhibition Fair (A3 format) Information reception for the catalog on July 15, 2017.
4. Workplace	Includes 2 sq.m. of not equipped area, 4 table, 2 chairs
5. Types of stands	Minimum standard booth area - 6 sq.m. Minimum non-equipped area - 6 sq.m. Standard booth is offered with the following packaging: wall panels on (6x2,5) m stand perimeter; 1 table and 2 chairs on each 6 sq.m. of the area; 2 stools per 6 square meters; curtain covering; hook for garments. For the corner booth (opened from two sides) is a shortage of 10% of the size of the stand.
6. Registration fee	Includes all organizational expenses: Budget for exhibition Placement of information (up to 50 words) about the Exhibitor in the Official catalog of the Exhibition Fair (A3 format). Placement of information on the official website of the organizer Information reception for the catalog on July 15, 2017.
7. Payment procedure for participation	Exhibitor will pay the deposit of 70% of the contract after the signing of contract. Final calculation will be made in Moscow at the rate of National Bank of the Republic of Tajikistan on the day of conclusion of the contract application.

8. Refusing of participation	Refusal of participation is accepted only by stamped and signed letter from management of the Company. In case of refusal from participation in the Exhibition Fair not later than 60 days prior to the Exhibition Fair, Exhibitor will return the paid amount, except of tax charges and expenses upon the procurement of information about the exhibition in the official catalog. If the Exhibitor refuses participation in the Exhibition Fair less than 60 days prior to the start, paid amount will not be returned.
9. Responsibilities of the parties	Participant's rights can not be transferred to another person. The participant has no right to transfer the provided area, and also to hand over it to someone in whole or in part without written coordination with the Organizer (Chamber of Commerce and Industry of the Republic of Tajikistan). The participant bears property responsibility for damage of the exhibition equipment and property. The participant bears responsibility for compliance of fire safety regulations, safety measures and sanitary standards. In case of violation the Participant pays all the penalties which are applied by corresponding control authorities, and also compensates the cost of the caused damage.
10. Additional information	All exhibitions and fair goods, imported for Exhibition Fair are placed in "Temporary Admission" mode and must be imported in the same condition. In this case the exhibitor is exempt from payment of Customs duties and taxes. During the exhibition days, if imported goods or part of them will be sold, then you should pay the customs duties and taxes for the sold goods in accordance with the current legislation of the Republic of Tajikistan. Exhibitor is obliged to have a certificate of compliance, standards or other documents certifying an origin and quality of exhibit goods. Certificates must be translated into Tajik or Russian languages.
11. Force majeure situations	The Chamber of Commerce and Industry of the Republic of Tajikistan doesn't bear responsibility for losses, damage or the delays which result from natural disasters, war, military operations, revolution, civil unrest, prohibition or obstructive acts of administrative authorities and etc. The force majeure circumstances concerning or breaking holding a Exhibition Fair. In this case the Chamber of Commerce and Industry of the Republic of Tajikistan reserves the right to postpone the date of exhibition for a later time. Amount paid to the Chamber of Commerce and Industry of the Republic of Tajikistan related the holding an exhibition fair will not be returned.
